## V-STEP UP: CLASSICAL DANCE BATTLE (SOLO)

### 1. Event Overview

V-Step Up: Classical Dance Battle (Solo) is a competitive platform celebrating the richness of Indian classical dance traditions. The event emphasizes artistic expression, rhythmic precision, technical mastery, and stage presence. Participants compete through structured rounds, culminating in a high-intensity final battle judged by an expert panel.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Eligibility

- The event is open to students aged 18 years and above.
- Participants from VIT-AP University and other universities/colleges are eligible.

### 3. Registration

- Registration must be completed individually.
- Registration fees differ for internal and external participants, as per the official fee structure.
- Registration will be considered valid only after successful payment and confirmation.
- Internal participants who complete registration after the Semi-Final Round will not be considered eligible for the Final Round. In such cases, the registration fee will be non-refundable.

### 4. Classical Dance Forms Allowed

Participants may perform any recognized Indian classical dance form, including but not limited to:

- Bharatanatyam
- Kuchipudi
- Kathak
- Odissi

Fusion with non-classical styles is strictly prohibited in the Semi-Final and Final Rounds

### 5. Round Structure & Time Limits

#### 5.1 Prelims Round

(Applicable ONLY to VIT-AP University students)

#### Eligibility

- Conducted exclusively for VIT-AP University participants
- External participants are exempted from the Semi-Final Round



## V-STEP UP: CLASSICAL DANCE BATTLE (SOLO)

### Purpose

- To shortlist the best internal performers for the Final Battle Round

### Mode of Performance

- Individual performance
- Performances must strictly adhere to classical dance forms
- Fusion elements or battle-style interaction are not permitted

### Time Limit

- 3-4 minutes per participant
- Time includes stage entry and exit

### Costume

- Wearing a proper classical costume is mandatory

### 5.2 Final Battle Round

#### Eligibility

- Shortlisted participants from VIT-AP University (via Semi-Finals)
- All external participants receive direct entry
- No Semi-Final round will be conducted for external participants

### 6. Mode of Performance – Final Battle

Format: One-on-One Classical Dance Battle

Costume: Full classical presentation with approved attire

#### Round I: Individual Opening Performances (2 minutes)

- Participant performs a prepared classical sequence for 2 minutes
- Participants may use their own prepared music

#### Evaluation Focus

- Technique
- Rhythm (Tala)
- Expression (Abhinaya)

#### Round II: Final Combat Performance – Common Track - (4-5 minutes)

(This round will be catered for the shortlisted two(2) participants that will battle for the final round.)

- A common two-minutes music track will be provided by the organizing team in advance (in the respective google drive link)
- Final 2 shortlisted participants must choreograph a concluding combat-style classical performance
- This phase serves as the decisive battle segment



## V-STEP UP: CLASSICAL DANCE BATTLE (SOLO)

### 7. Music Guidelines

- Music must be submitted to the stage committee at least two (2) days in advance
- The same music track cannot be repeated across rounds
- Only pure classical compositions are permitted in the Semi-Final and Final Rounds

### 8. Costume & Props

- Participants must arrange their own costumes and props
- Classical costumes relevant to the chosen dance form are strongly recommended
- Props are permitted provided they:
  - Do not damage the stage
  - Do not pose any safety risk
- No reimbursement will be provided for costumes or props

### 9. Code of Conduct

- Any form of vulgarity, inappropriate gestures, or indecent costume will lead to immediate disqualification
- Fusion with non-classical beats is strictly prohibited in the Semi-Final and Final Rounds
- All costumes are subject to approval by the organizing committee

### 10. Judging Criteria

Participants will be evaluated based on:

- Technique and rhythmic accuracy (Tala)
- Expression (Abhinaya)
- Grace, posture, and body control
- Adherence to classical form
- Overall stage presence

### 11. Decision & Authority

- The decision of the judges and organizing committee shall be final and binding
- The organizing committee reserves the right to:
  - Do not damage the stage
  - Do not pose any safety risk
  - Do not damage the stage

### 12. Important Note

Participants must provide valid and reachable contact details during registration to ensure timely communication regarding schedules, music submission, and updates.



### 13. Additional Guidelines

- Participants are advised to arrive at least 60 minutes before the scheduled performance time
- A brief sound check may be conducted at the discretion of the stage committee
- Participants should keep a backup copy of their music (pen drive + phone)
- Warm-up areas will be limited; participants should plan accordingly
- Any violation of time limits may attract penalty marks
- Green room for costume change will be available in the campus

## V-STEP UP: WESTERN DANCE BATTLE (SOLO)

### 1. Event Overview

- V-Step Up: Western Dance Battle (Solo) is a high-energy competitive platform that celebrates Western dance forms through creativity, musicality, freestyle expression, and performance attitude. The event follows a structured battle format, where solo dancers compete across rounds, leading to a high-intensity final battle judged by an expert panel.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Eligibility

- Open to students aged 18 years and above
- Participants from VIT-AP University and other universities/colleges are eligible

### 3. Registration

- Registration must be completed individually
- Registration fees differ for internal and external participants, as per the official fee structure
- Registration will be considered valid only after successful payment and confirmation
- Internal participants who complete registration after the Semi-Final Round will not be considered eligible for the Final Round. In such cases, the registration fee will be non-refundable.

Participants may perform any recognized Western dance style, including but not limited to:

### 5. Round Structure & Time Limits

#### 5.1 Prelims Round

(Applicable ONLY to VIT-AP University students)

##### Eligibility

- Conducted exclusively for VIT-AP University participants
- External participants are exempted from the Semi-Final Round

##### Purpose

- To shortlist the top Western dance performers from VIT-AP University for the Final Battle Round

##### Mode of Performance

- Individual performance
- Performances must strictly adhere to Western dance vocabulary
- Battle-style interaction is not permitted in this round

##### Time Limit

- 3-4 minutes per participant
- Time includes stage entry and exit

##### Costume

- Appropriate Western dance attire is mandatory
- Indecent or inappropriate costumes are strictly prohibited

#### 5.2 Final Battle Round

##### Eligibility

- Shortlisted participants from VIT-AP University (via Semi-Finals)
- All external participants receive direct entry
- No Semi-Final round will be conducted for external participants

### 6. Mode of Performance – Final Battle

Format: One-on-One Western Dance Battle

Costume: Full Western dance presentation with approved attire

#### Round I: Individual Opening Performances (4-5 Minutes)

- Participant performs a solo Western dance sequence for 2 minutes each.
- Participants may use their own prepared music

##### Evaluation Focus

- Musicality
- Groove and rhythm
- Originality and confidence



## V-STEP UP: WESTERN DANCE BATTLE (SOLO)

Round II: Final Combat Performance – Common Track (4-5 Minutes)

(This round will be catered for the shortlisted two(2) participants that will battle for the final round.)

- A common two-minutes Western music track will be provided by the organizing team in advance

- Final two shortlisted participants must choreograph a concluding combat-style western performance.
- Participants must choreograph a high-impact concluding combat performance.
- This phase serves as the decisive battle segment.

### 7. Music Guidelines

- Music must be submitted to the stage committee at least two (2) days in advance
- The same music track cannot be repeated across rounds
- Lyrics must be clean and appropriate for a university audience

### 8. Costume & Props

- Participants must arrange their own costumes and props
- Props are permitted provided they:
  - Do not damage the stage
  - Do not pose safety risks
- No reimbursement will be provided for costumes or props

### 9. Code of Conduct

- Any form of vulgarity, offensive gestures, or inappropriate lyrics will result in immediate disqualification
- Performers must maintain professional behaviour and sportsmanship
- Dress code and performance conduct will be monitored and approved by the organizing committee

### 10. Judging Criteria

- Participants will be evaluated on:
  - Musicality and rhythm
  - Execution and control
  - Freestyle creativity
  - Stage presence and confidence
  - Overall battle impact



## V-STEP UP: WESTERN DANCE BATTLE (SOLO)

**Note:** The above judging criteria are subject to modification based on the rubrics set by the internal and the external judges.

### 11. Decision & Authority

- The decision of the judges and organizing committee shall be final and binding
- The organizing committee reserves the right to:
  - Modify the event format
  - Drop any round
  - Make changes based on venue or participation requirements without prior notice

### 12. Important Note

- Participants must provide valid and reachable contact details during registration to ensure timely communication regarding schedules, music submission, and updates.

### 13. Additional Guidelines

- Participants are advised to carry backup music (pen drive and phone)
- Floor work must be performed with caution to avoid injuries
- Any intentional obstruction of the opponent's movement may attract penalties
- Participants should be ready backstage at least 30 minutes prior to their scheduled battle
- Exceeding time limits may result in point deduction
- Green room for costume change will be available in the campus

## V-Step Up: Classical Dance Battle (Group)

### 1. Event Overview

- V-Step Up: Classical Dance Battle (Group) is a competitive group dance event rooted in Indian classical dance traditions. The event highlights synchronisation, rhythmic precision, expressive storytelling, formations, and collective stage presence. Teams compete through structured rounds, culminating in a high-energy group battle judged by an expert panel.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Eligibility

- Open to students aged 18 years and above
- Participants from VIT-AP University and other universities/colleges are eligible
- Each team must consist of a minimum of 4 and a maximum of 8 members

### 3. Registration

- Registration must be completed team-wise
- Registration fees differ for internal and external teams, as per the official fee structure
- Registration is valid only after successful payment and confirmation
- Team members cannot be changed after registration under any circumstances
- Internal participants who complete registration after the Semi-Final Round will not be considered eligible for the Final Round. In such cases, the registration fee will be non-refundable.

- Battle-style interaction is not permitted

##### Time Limit

- 4- 5 minutes per team.
- Time includes stage entry and exit

##### Costume

- Uniform classical costume for all team members is mandatory

#### 5.2 Final Battle Round

##### Eligibility

- Shortlisted participants from VIT-AP University (via Semi-Finals)
- All external participants receive direct entry
- No Semi-Final round will be conducted for external teams

### 6. Mode of Performance – Final Battle

Format: Group vs Group Classical Dance Battle

#### Round I: Team Opening Performances (4 Minutes)

- Team performs a prepared classical group sequence for 4 minutes
- Teams may use their own prepared music

**Round II: Final Combat Performance – Common Track (4-5 minutes)**

(This round will be catered for the shortlisted two(2) participants that will battle for the final round.)

Teams will be evaluated on:

- Synchronisation and coordination
- Rhythm (Tala) and musical alignment
- Formations and transitions
- Expression and thematic clarity
- Overall stage impact

**Note:** The above judging criteria are subject to modification based on the rubrics set by the internal and the external judges.

### 11. Decision & Authority

- The decision of the judges and organizing committee shall be final and binding
- The organizing committee reserves the right to:
  - Modify the event format
  - Drop or add rounds
  - Make changes based on logistical or venue requirements without prior notice

### 12. Important Note

Team leaders must provide valid and reachable contact details during registration to ensure timely communication regarding schedules, music submission, and updates.

### 13. Additional Guidelines

- Teams should appoint one official team leader for coordination
- Teams must maintain clear formations to avoid overcrowding the stage
- Backup copies of music are strongly advised
- Any intentional obstruction of the opposing team's performance may attract penalties

Teams compete through structured rounds, culminating in an intense group-versus-group battle evaluated by an expert judging panel.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Eligibility

- Open to students aged 18 years and above
- Participants from VIT-AP University and other universities/colleges are eligible
- Each team must consist of a minimum of 4 and a maximum of 10 members

### 3. Registration

- Registration must be completed team-wise
- Registration fees differ for internal and external teams, as per the official fee structure
- Registration is valid only after successful payment and confirmation
- Team members cannot be changed after registration under any circumstances
- Internal participants who complete registration after the Semi-Final Round will not be considered eligible for the Final Round. In such cases, the registration fee will be non-refundable.



## V-Rhythm: Classical Rhythm Battle (Solo)

Participants compete through structured rounds, culminating in a one-on-one final rhythm battle judged by an expert panel.

### 2. Eligibility

- Open to students aged 18 years and above
- Participants from VIT-AP University and other universities/colleges are eligible

### 3. Registration

- Registration must be completed team-wise
- Registration fees differ for internal and external teams, as per the official fee structure

- Shortlisted participants from VIT-AP University (via Semi-Finals)
- All external participants receive direct entry
- No Semi-Final round will be conducted for external participants

### 6. Mode of Performance – Final Battle

Format: One-on-One Classical Rhythm Singing Battle

Costume: Full Western dance presentation with approved attire

#### Round I: Individual Opening Performances (3 Minutes)

- Participant performs for 3 minutes
- Participants may present their own prepared composition

##### Evaluation Focus

- Pitch accuracy
- Raga development
- Tala discipline

## V-DESIGNERS: CYBERPUNK 2030

### 1. Event Overview

- V-Designers: Cyberpunk 2030 is a futuristic design showcase inspired by technology, cyber culture, artificial intelligence, dystopian futures, and digital identities. The event is conceived as an interdisciplinary platform where fashion serves as a medium to express innovation, systems thinking, and speculative future narratives.
- Participants are encouraged to explore the intersection of design, technology, and imagination, transforming conceptual ideas into wearable, future-forward creations.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Eligibility

- Open to students pursuing an undergraduate degree or higher
- Participants may belong to any academic discipline, including but not limited to:
  - Engineering / B.Tech
  - Design & Architecture
  - Sciences
  - Humanities & Social Sciences
  - Media, Arts, and allied fields
- No prior fashion background is required
- Innovation, concept clarity, and creative thinking are the primary focus

### 3. Theme

Theme: **CYBERPUNK 2030**

Participants are expected to interpret the theme through concepts such as:

- Futuristic urban life and dystopian environments
- Human-machine interaction and artificial intelligence
- Digital identities, surveillance, and cyber culture
- Technology as power, rebellion, or transformation

Designs may draw inspiration from:

- Engineering logic
- Digital systems

All designs must remain safe, wearable, and stage-appropriate.

Participants are encouraged to begin preparation well in advance. The design process should reflect clear conceptual development, not just the final garment.

#### Mood Board & Inspiration Process (*Strongly Recommended*)

- Participants may create a mood board or concept board representing:
- Source of inspiration
- Conceptual narrative linked to Cyberpunk 2030
- Evolution of the idea from concept to final design

Mood boards may include:

- Visual references (technology, architecture, cyber imagery, dystopian worlds)
- Colour palettes and textures
- Fabric and material exploration
- Silhouette and form studies
- Accessory and styling concepts

Mood boards are not mandatory, but are strongly recommended to communicate the designer's creative journey.

Designs should demonstrate cohesion between clothing, accessories, and styling.

Participants are encouraged to:



## V-STAND UP COMEDY

### 1. Event Overview

- V-Stand Up Comedy is a solo performance event that celebrates wit, originality, spontaneity, and stage presence. The platform invites students to present their unique sense of humour through observational comedy, storytelling, satire, and everyday experiences.
- The event encourages clean, creative, and engaging humour, allowing performers to connect with the audience while expressing individuality and confidence.
- Participants will be evaluated by an expert panel based on content originality, comic timing, delivery, and audience engagement.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Eligibility

- Open to individuals aged 18 years and above
- Participants must have a genuine interest in stand-up comedy
- All participants must strictly adhere to content appropriateness guidelines

### 3. Registration

- Registration must be completed before the specified deadline
- Registration fees differ for internal and external participants, as per the official fee structure
- Registration will be considered valid only after successful submission and confirmation
- Internal participants who complete registration after the Semi-Final Round will not be considered eligible for the Final Round. In such cases, the registration fee will be non-refundable.

- All comedy material must be original
- Plagiarism or copyright infringement is strictly prohibited
- Content must be appropriate for a diverse university audience

- Offensive or abusive language
- Hate speech
- Explicit, obscene, or inappropriate material



## V-STAND UP COMEDY

### 5. Time Limits

- Each comedian will be allotted a specific time limit for their performance
- Exceeding the prescribed time limit may result in:
  - Point deduction, or
  - Disqualification, at the discretion of the judges

### 6. Audition Round

- An audition round may be conducted depending on the number of registrations
- Participants must prepare a short segment of their routine for auditions
- Selection will be based on:
  - Content quality
  - Delivery
  - Audience connection

### 7. Performance Criteria

Participants will be judged on:

- Originality of content
- Delivery and comic timing
- Stage presence
- Audience engagement
- Overall comedic impact

Props and audio-visual aids may be used; however, they must not dominate or overshadow the performance.

**Note:** The above judging criteria are subject to modification based on the rubrics set by the internal and the external judges.

### 8. Language & Cultural Sensitivity

- Participants must be mindful of language usage
- Comedy performances may be delivered in Tamil, Telugu, Hindi, or English, or a combination of these languages.
- Jokes or content targeting:
  - Race
  - Ethnicity
  - Gender
  - Religion
  - Any sensitive social group are strictly prohibited

Respect for cultural and social diversity must be maintained at all times.



## V-STAND UP COMEDY

### 9. Dress Code

- Participants are encouraged to dress appropriately and comfortably
- Attire should be suitable for a formal stage performance and university audience

### 10. Props & Special Effects

- Props and special effects are permitted
- They must:
  - Not disrupt the flow of the event
  - Not pose any safety risk
  - Not distract from the core performance

### 11. Code of Conduct

- Participants must maintain professional behavior and mutual respect towards:
  - Fellow participants
  - Event organizers
  - Audience members
- Any disruptive or inappropriate conduct may result in immediate disqualification

### 12. Time Management

- Prelims Time Limit: 5 minutes
- Finals Time Limit: 5 minutes

Participants must be punctual for:

- Rehearsals
- Fittings (if any)
- Actual performance

Late arrival may result in penalties or disqualification

### 13. Decision & Disqualification

- All decisions made by the judging panel shall be final and binding
- The organizing committee reserves the right to disqualify any participant for:
  - Rule violations
  - Unacceptable behaviour
  - Content that breaches event guideline

### 14. Additional Guidelines



## V-NUKKAD NATAK (STREET PLAY)

### 1. Event Overview

- V-Nukkad Natak is a street play competition designed to raise awareness about important social issues through impactful theatrical performances. The event emphasizes strong messaging, audience engagement, vocal projection, and expressive storytelling using traditional street theatre techniques.
- Teams perform in an open-air setting, blending skits, dialogues, songs, dance, and slogans to convey meaningful social messages in an engaging and powerful manner.

This event is conducted as part of VITOPIA 2026 – Prime Cultural Events.

### 2. Team Composition

- Each team must consist of a minimum of 7 and a maximum of 12 members
- Registration fees differ for internal and external participants, as per the official fee structure
- Participants may access additional event-related details, reference materials, formats, and updates through the official Google Drive link: [https://drive.google.com/drive/folders/1jnL-Hpq00Ffi\\_2P92FzYGjdZqzQdzhs8?usp=drive\\_link](https://drive.google.com/drive/folders/1jnL-Hpq00Ffi_2P92FzYGjdZqzQdzhs8?usp=drive_link)
- Internal participants who complete registration after the Semi-Final Round will not be considered eligible for the Final Round. In such cases, the registration fee will be non-refundable.

### 3. Theme

- Performances must be based on a socially relevant theme
- The act should aim to communicate a clear and impactful message to the audience
- Themes may address:
  - o Social awareness
  - o Public issues
  - o Ethical concerns
  - o Community engagement



## V-NUKKAD NATAK (STREET PLAY)

### 4. Competition Structure

#### 4.1 Prelims Round

*(Applicable ONLY to VIT-AP University teams)*

- Conducted exclusively if the number of internal entries is high
- Teams may be required to perform:
  - A shortened version of their street play, or
  - A highlight performance showcasing the theme, key scenes, and engagement elements

#### 4.2 Final Round

- Performance slots will be communicated to teams in advance

### 5. Performance Duration

- Each performance must be between 8 and 14 minutes
- The time limit includes:
  - Entry
  - Setup
  - Performance
  - Exit

Exceeding the time limit will result in negative marking

### 6. Performance Guidelines

- Teams may incorporate:
  - Skits and dialogues
  - Songs and rhythmic elements
  - Slogans and group narration
- Use of props such as:
  - Placards
  - Banners
  - Costumes
  - Musical instruments is permitted
- Drums will be provided by the organizers; teams may bring additional instruments if required
- Performances will be conducted in an open-air setting
- No sound systems will be provided; teams must ensure strong voice projection



## V-NUKKAD NATAK (STREET PLAY)

- Performances may be conducted in:
  - o Hindi
  - o Telugu
  - o Tamil
  - o English
  - o Or a combination of these languages provided the message remains clear and accessible

**Note:** The above judging criteria are subject to modification based on the rubrics set by the internal and the external judges.

### 7. General Instructions

- Performances must reflect the true spirit of Nukkad Natak—direct, engaging, and impactful
- Content must be appropriate, respectful, and socially responsible
- Any content promoting:
  - o Violence
  - o Hatred
  - o Offensive or discriminatory messaging will result in disqualification

### 8. Decision & Authority

- The decision of the judging panel and organizing committee shall be final and binding
- The organizing committee reserves the right to:
  - o Modify rules or schedules
  - o Enforce changes based on logistical or venue requirements without prior notice

### Additional Guidelines

Teams should appoint one spokesperson or team leader for coordination

- Loud, clear diction and synchronized chanting are strongly encouraged
- Props should be lightweight and easy to assemble/disassemble
- Teams should rehearse voice projection considering the absence of microphones
- Avoid blocking audience visibility during performances
- Teams are advised to arrive at least 45 minutes before their allotted slot
